Senior Center Report

Tringali reported on the March 6th ReXpo and Senior Art Show. Staff estimated attendance of 500-700 for both events, with good traffic flow through the Senior Art Show. The new set up for the event was successful and the Food Trucks were popular. Jan Bellows held a flower arranging class with 12 participants

plus one grandson. Senior Center, Inc. Hand and Foot card party fundraiser is sold out. Tax Aid only has four spots left to fill. Commissioner Overholt suggested that the overflow of request for Tax Aid be sent to Centers for Families. Tringali is working with Woodland PD and Yolo County District Attorney to schedule a resource fair in the gym related to fraud protection. Engel informed the Commission that City Council will appoint a new COA Commissioner at the March 17th City Council meeting. New Commissioner should attend the next COA meeting in April. Commissioner Sanborn stated that SCI had found an instructor for training seniors on the new cell phones. Training will be available every Friday in April, 1-3:30 p.m.

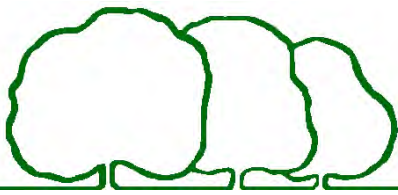

BACKGROUND INFORMATION:

The following provides highlights of the Senior Center since the last report.

Senior Resource Fair: There are currently over 50 applications that have come in for vendors taking part in the Senior Resource Fair on May 28. Recent applicants include Citizens Who Care, Yolo Adult Day Health Center, Woodland Stroke Support, and Woodland Care Car.

1-on-1 Tech Help for Seniors: Staff has worked with the Commission on Aging to offer individual consultations for assistance with smart phones, tablets, and other technology. Appointments take place in the Senior Center consultation room on Fridays between 1:00-3:00 p.m. The technology volunteer's name is Pan Soonsawad. The Welcome Desk will schedule members in person and over the phone.

Travel Presentations: The Senior Center contracts with the Collette travel agency to offer world-wide trips to seniors. On Thursday April 16 at 1:30 p.m., a member of the Collette team will come to the senior Center to conduct a presentation on all of their upcoming trips. Senior Center Inc.'s "Affordable Adventures" program will be there to present their excursions as well.

New Class: Starting May 5, the Senior Center will offer a greeting card making class with instructor Mona Moretto. This will take place on Tuesdays from 10:00-11:30 a.m. for \$5 per month. Mona will provide participants with all of the materials they will need. Registration is taken at the Community Services front desk.

Returning Support Group: The Peripheral Neuropathy support group will continue offering support and resources at the Senior Center. The group went on hiatus and will now continue under new leadership starting on Tuesday April 7th. They will meet regularly the first Tuesday of the month at 1:30 p.m.

Senior Center Events: Staff has prepared a comprehensive list of senior center events for 2015 and 2016. Commission is requested to take note of all upcoming dates and support senior events.
