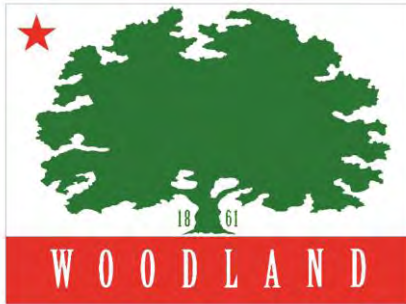

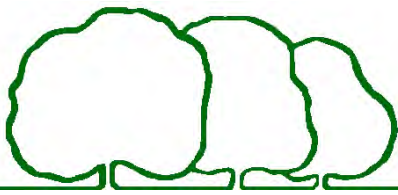

Program Report
