SPECIAL ADVISORY REDISTRICTING COMMISSION

PLEASE NOTE: The January 3, 2022 Special Advisory Redistricting Commission meeting will be conducted pursuant to Government Code section 54953(e), which allows the City to hold meetings via teleconference during a proclaimed state of emergency, when state or local officials have imposed or recommended measures to promote social distancing.

The meeting will be held via teleconference and Commissioners and the public will participate via teleconference. Those locations are not listed on the agenda and are not accessible to the public.
