On a motion by Vice Mayor Stallard, seconded by Council Member Hilliard, and carried unanimously the Council adopted Resolution 6201, "A Resolution of the City Council of the City of Woodland Approving a Variance from the City of Woodland Floodplain Management Ordinance for an Agricultural Building Located at 1460 Churchill Downs"

7. SUBJECT: Business License Fee Schedule

Recommendation for Action: Staff recommends that the City Council hold a public hearing to adopt a Resolution to approve the state's mandated Disability and Education Revolving Fund surcharge be included within the City's Comprehensive Fee Schedule

On a motion by Council Member Marble, seconded by Council Member and carried unanimously Council adopted Resolution 6202, "A Resolution of the City Council of the City of Woodland Adopting that the State's Disability Access and Education Revolving Fund Surcharge be Included within the City of Woodland Comprehensive Fee Schedule"

9. SUBJECT: City Storm Drain System Operations and Stormwater Regulatory Requirements

Recommendation for Action: Staff recommends that the City Council receive an update on the potential for the new storm drain system permit requirements and provide staff direction regarding additional information or actions desired

10. SUBJECT: Yolo County Habitat Conservation Plan Joint Powers Agency Update

Recommendation for Action: Staff recommends that the City Council 1) receive the status update on the Yolo County Habitat Conservation Plan Joint Powers Agency; 2) authorize an appropriation not-to-exceed \$160,000 from the General City Development Impact fee fund for the city's share of member agency contributions requested to continue JPA activities through completion of the HCP/NCCP Administrative Draft Plan (June 30, 2012), and direct staff to ensure appropriate nexus to recover the value of the city's contribution through allowable fees from future development activities

On a motion by Council Member Denny, seconded by Council Member Hilliard and carried unanimously, Council so approved.
